# 1. Status of Prop 84 Rounds 2&4

- Proposition 84, Round 2 complete.
- Proposition 84, Round 4:
  - Projects 7 and 8 working through some scheduling updates.
  - Project 9 has submitted its draft completion report to DWR.
- AQPI:
  - NOAA installing 10 new rain gauges associated with AQPI.
  - SCRIPS meetings taking place on July 26 and August 16.
  - Three radars are pending installation.
  - DWR is issuing a no-cost extension for the related grant project.

# 2. Status of Prop 1 Implementation Funding

- Proposition 1, Round 1:
  - Quarterly submittal due July 31

- Proposition 1, Round 2:
  - San Mateo RCD and Partners can assist SFEP with covering additional admin not allowed by DWR. This solves an outstanding issue and allows SFEP to continue to be the grant administrator for Prop 1, Round 2 for the Bay Area IRWM.
  - SFEP replied to DWR with acceptance of award notification.
  - DWR is working on agreements with IRWM regions.

## 3. Status of Prop 1 IRWM DACTIP

- Invoicing:
  - Invoice #22 submitted to state for final three DACTIP partners.
  - total of 272 invoices received by partners.
  - Invoice #23 (final invoice) will go to the state with final admin costs soon.
- Grant term for DACTIP has now expired.
- Final reports for DACTIP (grant completion report and TAP water quality testing report) being prepared.

#### 4. Functional Area Representatives
