Status of Prop 84 Rounds 4 & AQPI

Prop 84 Round 4 (James Muller)

- Project 7 is under construction currently; slated to close out March 2026; just submitted first match invoice to DWR
- Project 8 is currently closing out; SFEP is working with LPS on final invoicing/deliverables/project completion report
- Reminder, round closes out March 31, with final deliverables due June 2026

AQPI (Brian Mendenhall)

- Radar deployments
 - X-Band radar deployed on Sawyer Ridge in San Mateo County. The radar is not online yet at CW3E <https://cw3e.ucsd.edu/Projects/AQPI/main.html>. However, that should be remedied by the rainy season.
 - C-Band radar is currently being deployed on Mt. Barnabe in Marin County. Sonoma Water's

contractor is at work preparing the site per the approved permit. The radar should be placed at the site in October.

- System Improvements

- Sonoma Water and CW3E convened an AQPI Workshop at the end of June 2025 at Sonoma Water. It was well attended by a variety of water, wastewater, and flood control agencies from around the Bay. Agency representatives described how they are using AQPI data/reports to assess rainfall, streamflow, wastewater overflows.

- An on-line AQPI Users Group will take place at the end of September. If you'd like to be included, contact Jon Rutz of CW3E - jrutz@ucsd.edu

Administrative

- Sonoma Water is working with local agencies around the Bay to get an agreement in place for reimbursement of the deployment costs of the C-Band. The radar itself was covered under the DWR grant, however, deployment costs (permitting, engineering, site preparation, etc.) are ~1.2 million dollars.

- Sonoma Water & CW3E are working with local agencies for a long-term O&M agreement for AQPI once the DWR grant sunsets in June 2026.

Status of Prop 1 Implementation Funding

P1R1 (Leslie Perry)

- We are nearing the end of the grant, and all projects have billed for their full grant amount.
- Project 3 with Sonoma Water will be submitting their project completion report at the end of September
- Project 5 with EBMUD has draft of their project completion with us for review, we expect to submit it to DWR by the end of the week
- Project 6 with San Jose should have their retention check within the next month or two

P1R2 (Leslie Perry)

- We are still getting projects off the ground but one of the decision support tools billed for their full grant amount (Project 9) and will be the first project to close out in this round of funding. We will be working with them to close out the project in Spring 2026
- Amendment 3 is progress for Project 7 with SMRCD to shift funds between budget categories
- And for both Rounds of Prop 1 we are expecting quarterly submittals at the end of October
