1. Status of Prop 84 Rounds 4 & AQPI

Prop 84, Round 4 (N. Daniels):

- Site visit with DWR for Project 8, South San Francisco Bay Shoreline Project (South Bay Salt Ponds) went well on May 12. Project is expected to wrap up this summer
- Project 7, Mountain View Shoreline portion of the South Bay Salt Ponds project is set to begin this summer and expected to finish this fall
- Grant closes March 2026

AQPI (J. Krebs):

- Local partner agencies committee meeting was May 21
- Users group in June; please contact Jennifer Krebs if interested in attending
- Questions around how to fund ongoing support; installation was covered by DWR, looking for long-term operation and maintenance funding
- Radar installation – Sawyer Ridge in San Mateo County has contract for install going to the Board; C-Band on Barnabe Mountain in western Marin will be deployed in November

2. Status of Prop 1 Implementation Funding

Prop 1 Round 1 (L. Perry):

- Q17 materials are with DWR for review with an invoice for around \$900k
- The grant will close out June 2026 and most projects are wrapping up
- Lots of site visits! American Canyon, Calistoga, and San Jose last month for Project 3, 4, 6
 - Upcoming site visit in Petaluma on 6/5/2025 for Project 3

Prop 1 Round 2 (N. Daniels)

- Amendment with DWR/ABAG is in place; LPS sub-agreements are in varying stages of execution
- Q1 2025 materials with DWR with an invoice around ~\$1M
- Construction status in table in agenda packet shows % of projects complete; Zone 7's decision support tool projects are at 85% and 65%, Daily Acts is at 40%, MMWD is at 30%
