1. Status of Prop 84 Rounds 4 & AQPI

Prop 84 Round 4:

- Project 7 has invoiced for 2/3 of their match; project is on schedule to finish construction in January; ribbon cutting sometime in February 2026
- Project 8 is working on their final deliverables and project completion report; their agreement with ABAG ends this month
- Term is through March 2026

AQPI (Brian Mendenhall):

- Radar Deployment: The final C-Band radar was installed in November 2025 on Mt. Barnabe on the Marin Sonoma border. Can be viewed [here](#).

- AQPI Data, Software, etc.: CW3E, NOAA and CIRA are collaborating with local agencies to ensure that storm data is getting to the proper channels. CW3E is hosting monthly tech meetings to discuss storm data.
- An AQPI Celebration to be scheduled in February or March at SFPUC. Representatives of the IRWMP CC will be invited. More info to follow.
- The project will conclude in June 2026.

2. Status of Prop 1 Implementation Funding

Round 1- Wrapping up in June 2026

- Processing retention for Project 05 with EBMUD
- Scheduling field trip for Project 07 with the SFPUC in February
- Project 04 with the City of Calistoga will be presenting today- the last project to present in this round of funding!

Round 2 – Term goes through June 2028

- Zone 7's Wells Mocho Project 13 is in contract and invoicing for match
- Projects generally slow to get into construction, but we've spent 12% of grant funds
- Amendment 3 is in the works to shift budget for SMRCD's Project 7

3. Functional Area Representative Recruitment & Update

Brian Mendenhall shared background on why we're going through this process and noted that the CC needs to have a complete and active list of functional area representatives in preparation for the next round of IRWM funding via Prop 4. Preparing the CC for the next funding opportunity will ensure that we have robust interest, input and direction from regional partners as that funding is pursued. Valley Water has always assisted with the four functional areas – flood protection/stormwater, wastewater/recycled water, water supply/water quality, and watershed. We've traditionally had three reps in each functional area from agencies and also larger bodies such as BACWA and BAFPAA. In recent years, the CC has added three seats each for Tribal and Disadvantaged Community (DAC) representatives. If we need a vote in the future (rarely have we needed voting), we will want to have each of the functional areas represented.

Jarrad Fisher of San Mateo Resource Conservation District volunteered for Watershed. Kevin Padway volunteered for Water Supply. Kyle Pickett of Mountain View Sanitation District could be a wastewater alternate. Gina Williams of GirlWritesLLC would be happy to be a volunteer. We'll send out an email following the meeting with a call for volunteers. We'll remind members on the IRWM listserv at the end of the year and may reach out individually if need be. The final updated list will be shared at the February 2026 meeting.

Action items: send out a call for functional area reps (SFEP)

4. Presentation for ITWM Prop 1 Round 1 Project 5, City of Calistoga

David Fradelizio presented on progress under Prop 1 Round 1, which includes 3 sub-projects for City of Calistoga. See the BAIRWMP website for presentation.

5. Announcements and Next Steps

- Roundtable of Regions – next meeting is 12/10/25. Brian Mendenhall will be attending, and the meetings are useful for providing Prop 4 funding information.
- Prop 4 – some funding coming out through some other non-DWR agencies. DWR is still working on guidelines.
- Future meeting schedule – thinking of moving to a quarterly meeting schedule since we haven't had funding recently which will provide for more robust discussions. Proposed new meeting schedule:
 - February 23, 2026
 - May 18, 2026
 - August 24, 2026
 - November 20, 2026
- Question on need to update the IRWM Plan for Prop 4 (no immediate need to update).
- Question on the process around getting a project on the adopted project list – all projects that apply for grant funding through the IRWM will need to be on the adopted project list, which is a fairly informal process.
